- (c) The necessary equipment and other relevant infrastructure required to execute the project;

- (e) Having the legal capacity to enter the contract with BEDC;
- (f) Are not in receivership, the subject of any form of insolvency or bankruptcy proceedings or the subject of any form of winding up petition or proceedings;
- (g) Do not have any director who has been convicted in any country for any criminal offense relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter.
