- i. Evidence of company registration (certificate of incorporation of the company) including forms CAC2 and CAC7;
- ii. Duly certified company Audited Accounts for the last 3years (2018, 2019, 2020);
- iii. Evidence of company income Tax Clearance Certificate for the last three years (2018, 2019 and 2020) with a minimum average turnover of N75,000,000.00;
- iv. Evidence of PENCOM Compliance certificate expiring by December 2021
- v. Evidence of ITF Compliance Certificate expiring by December 2021;
- vi. Evidence of NSITF Compliance certificate expiring by December 2021;
- vii. Evidence of dealership certificate from recognized brand
- viii. Sworn affidavit disclosing whether or not any officer of the relevant committees of the National Agency for the Control of Aids or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
